	Goals	Role(s)
1.	Recognizes and manages emergency conditions (extremely ill patient), triages accurately, resulting in prompt and appropriate treatment; diagnostic tests and therapeutic interventions are appropriate and consultative services are usually appropriately consulted. Remains calm, acts in a timely manner and prioritizes correctly	Medical Expert
2.	Demonstrates accurate ACLS protocols while managing cardiac arrest & pre-arrest	Medical Expert
3.	Overall is proficient and efficient in technical and procedural skills. Minimizes risks and discomforts to the patient. (e.g. endotracheal intubation; resuscitation of critically ill patient; repair of soft tissue wounds; chest tube insertion; central line insertion; nasal packing; drainage of peritonsillar abscess; tracheotomy/cricothyroidotomy; conscious sedation)	Medical Expert
4.	Performs effective history and physical exam, and radiological assessment related to injuries associated with facial trauma (C-spine, ocular)	Medical Expert
5.	Manages head & neck emergencies (e.g. airway emergencies; acute facial fractures; acute upper digestive tract compromise; acute external/middle ear pathology (OE/OM/trauma); acute intranasal pathology [epistaxis]; acute intra-oral pathology [lacerations, infections, abscess]; acute neck injury [penetrating and blunt trauma/laceration])	Medical Expert
6.	Manages soft tissue infections	Medical Expert
7.	Obtains & synthesizes relevant history from patient and family	Communicator
8.	Dictates/writes clear consultation letters, progress notes, and discharge summaries	Communicator
9.	Explains procedures/treatments, options for treatment, complications and morbidity to patients and families in a clear and understandable form. Uses voice, body language, translators to good effect. Skillfully recognizes and manages communication challenges.	Communicator
10.	Work with cooperation and respect with physicians, nurses, therapists and other members of health care team; Effectively and clearly communicates basic management plans to other medical staff and allied health care professionals	Collaborator
11.	Provides thorough handover of all patients being transferred out of the emergency department to a different ward/service or to the next shift	Collaborator
